NOTES TO MATA MEMBERSHIP APPLICATION

1. Categories of Membership:

Membership in the Association shall be divided into the following categories:

- a) **Corporate** – Any company incorporated in Malaysia, engaged in the industry as automation parts and sub-system manufacturers and resellers, software vendors, system integrators, machine manufacturers and automation industry service providers.
- b) **Affiliate** – Any company incorporated in Malaysia, engaged with the industry but does not meet the requirements to be accepted as a Corporate member. Affiliate members shall have all rights and privileges of Corporate members except the right to hold office or to vote.
